



Family Child Care (FCC) provides quality, affordable and available child care for military families in safe and secure homes.

- **FCC** is an alternative to Child Development Centers (CDC) for families that need evening care, weekend care, care for children with special needs, infants, school-age children, and care during swing and midnight shifts. FCC is provided by trained, qualified spouses of military members who care for children ages 2 weeks to 12 years of age in their affiliated on and off-base homes. These trained professionals are allowed to care for up to 6 children, with no more than 2 under the age of two yrs. These ratios include their own children less than 8 yrs of age. FCC Providers are considered privatized contractors, with the ability to set their own rates, hours, and choice of customers. They work under DoD components and are therefore regularly screened, trained, and monitored by Air Force.
- Family Child Care provides **FREE PCS care** (Permanent Change of duty Station) for up to **20 hours per child within 60 days of PCS arrival/departure**. A referral certificate from the Airman & Family Readiness Center will have to be obtained, and submitted to an FCC Provider of the customer's choice. Customers are to make direct contact with any of our affiliated FCC Providers for child care arrangements. Current Providers lists are available through FCC, CDC, SAP, A&FRC, First Sergeants, or 24/7 on the outside of the FCC building.
- **Pre-Deployment Child Care (PDCC)** provides child care for children ages 12 and under. Up to 16 hrs of care per child is available to those Active Duty, National Guard, and Reserve members assigned to an AF or joint Base Air Force led installation prior to deploying in support of contingency operations for more than 30 days. To request care, the parent must complete the DM FCC ECC Registration and AF FCC ECC Sign-up forms and submit them with a copy of their orders to the FCC Director. Care arrangements depend on availability of open spots with FCC Providers; a two week processing time is highly encouraged.



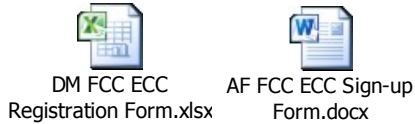

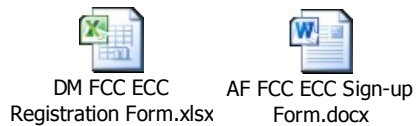

- **Deployment Child Care (DCC)** provides child care for children ages 12 and under. Up to 16 hours of care per child is available to those Active Duty, National Guard, and Reserve members assigned to an Air Force or Joint Base Air Force led installation during the member's deployment in support of contingency operations of more than 30 days. Care for DCC is provided in an Air Force Family Child Care (AF FCC) Home participating in the AF FCC

Expanded Child Care (ECC) Program. The 16 hours must be used during the deployment. To request care, the parent must complete the DM FCC ECC Registration and AF FCC ECC Sign-up forms and submit them with a copy of their orders to the FCC Director. Care arrangements depend on availability of open spots with FCC Providers; a two week processing time is highly encouraged.



- **Returning Home Care (RHC)** offers free child care of up to 16 hours per child to Airmen returning from deployment. Customers have 6 months upon their return to utilize this care with one of our designated Family Child Care (FCC) Providers. To request care, the parent must complete the DM FCC ECC Registration and AF FCC ECC Sign-up forms and submit them with a copy of their orders to the FCC Director. Care arrangements depend on availability of open spots with FCC Providers; a two week processing time is highly encouraged.



- **Home Community Care (HCC)** is an AF sponsored FCC program that offers free childcare for AFR and ANG members, in support of their monthly, primary UTA weekend. To request care, the parent must complete the DM FCC ECC Registration and AF FCC ECC Sign-up forms and submit them to the FCC Director. Care arrangements depend on availability of open spots with FCC Providers; a two week processing time is highly encouraged.



- **The Parent Advisory Board (PAB)** consists of parents who currently have their children enrolled in any of the Child and Youth Programs (CYP: FCC, CDC, SAP and YP). Interested parents meet on a quarterly basis with the Chief of the Airman & Family Services Flight and managers/trainers of those program activities to discuss child care related issues, ask questions, and share their opinions/concerns and to get information updates.
