SUBJECT: Air Force Services Camp Call (SUSPENSE: 29 Mar 13)

1. The Air Force (AF) Personnel Services Directorate is pleased to announce our camp call for 2013! We are making a single call for three camps to include Teen Aviation, Teen Leadership and Space Camp.
2. All of the camps have different eligibility criteria. General information sheets for each camp are attached (atchs 2-4). Eligible applicants include teen dependents of Active Duty Military assigned to or living on an Air Force/Joint Base Installation, AF Retired Military, AF Civilian Employees, activated Air National Guard or AF Reserve.
3. Teens interested in applying must complete the attached electronic Summer Camp Nomination Registration Form (atch 1), and submit the package to their installation Youth Programs. Youth or teens will complete the Nomination/Registration Form once but must annotate on the top of the form all camps of interest to them. Teens may only participate in one camp. The Youth Programs Director or designee will interview the applicants using the Verification of Eligibility and Interview Section at attachment 1. For Guard applicants, Ms. Barbara Lohr at DSN 612-7462, will conduct the interview.
4. After the SVI and MAJCOM review process has been completed, SVI and MAJCOM representatives are asked to upload submissions to the AF Services Personnel Directorate sharepoint. Please use designated camp folder within folder labeled Camp Applications 2013. Only applications in their original format with digital signature will be accepted. Scanned applications will not be accepted. Applications should be labeled with first initial, last name, and camp preference (cfisherTA1SP2TL3.doc or cfisherTL1.docx).
5. The AFPC/SVPY suspense for all three camps is 29 Mar 13. Final selections for spaces will be announced by 19 Apr 13.
6. All lodging, meals, and program costs will be centrally funded at no cost to participants or their installations. Airline or POV travel costs to each camp are the responsibility of the attendees or their installation.

7. These camps allow youth staff an excellent opportunity for additional learning experiences. Installation youth staff members will be selected to offer leadership and oversight during these exceptionally interactive and demanding camps. Costs for counselor TDYs will be funded by AFPC/SVPY. Interested staff should complete the attached Staff Nomination Form (atch 5) and forward to AFPC/SVPY by 29 Mar 13.
